

WEBSITE COOKIES POLICY

0. SCOPE

This document is intended for all users of the websites managed by INTEGRITY, S.A. (PT509072054, headquartered at Avenida D. João II, n° 43, 9º Piso, Parque das Nações, 1990-084 Lisboa, Portugal), whose trading name is Devoteam Cyber Trust (the cybersecurity unit of the Devoteam Group).

1. COOKIES POLICY

Through the present Cookies Policy (hereinafter "Policy"), you are informed that this [website](#) uses Cookies and/or similar technologies that store and retrieve information while you are browsing (hereinafter "Cookies").

2. COOKIES AND PURPOSE OF COOKIES

Cookies are procedures for collecting information about your visit to our website and are stored in your browser page, so that the website can consult your previous activity.

5. USE OF COLLECTED DATA

We use the collected data for the following main purposes:

The data collected shall be processed for the period strictly necessary to achieve the specific purpose of each one.

In cases where Cookies allow the identification of the user, we are the data controller only for the purpose of managing the specific function of each Cookie.
